### Florence Township Regular Monthly Meeting

The treasurer's report is as follows checking and money market account balance of \$193,490.27, receipts of \$9,094.59 and disbursements of \$41,468.69 for a total checking and money market balance of \$161,116.17. We have one CD for \$86,847.69 for a total cash and investments of \$247,963.86. There was a motion made and second to approve as presented. The motion passed.

Zoning-Kevin Carlson 20x30 garage at 35319 Farm View Street. Motion was made and second to approve. The motion passed.

Cory Mickelson-Build a detached garage 30x48 at 35259 Maury Avenue. A motion was made and second to approve. The motion passed.

Art Stubfors- Remove the top floor of double wide trailer 27x60 and add a new roof to make a workshop out of it. A motion was made and second to approve. Motion passed. 30798 Ski Road.

Dick Herron-33743 Germania Street build a garage 22x30 . He will need variances as the property is not large enough. A motion was made and second to approve if all County guidelines are met. Motion passed.

Heritage Commission-No business. We would like to get the Town Hall painted. Advertise for painting bids.

The resolution pertaining to building permits was read. There was a motion made and second to approve the resolution. The motion passed with amended date.

The new B-Wells sign is not in compliance with the new ordinance. The board is requesting that B-Wells pay the \$25.00 permit fee. A motion was made and second to have B-Wells the \$25.00 permit fee. The motion passed. Joe abstained from voting.

The wood pile has been burned in Valhalla park. There are still more logs that need to be cleaned up. Sven will see if he can use the wood.

Friends of the Town Hall-We are having more historical sites added to the County historic website. We have received more donations. There was a brewery on lake Pepin in the 1860's. It was on the John Mingis property. If anyone has any information on it please let us know.

Old Business-Lawn mowing Tom Holloway has offered to mow for \$12.00 an hour. Jim will contact Tom Holloway and ask if he will accept \$10.00 and hour. A motion was made and second to table until we talk to Tom Holloway. Motion passed.

We are trying to find volunteers to work in the gardens by the gas station and the one on the other end of town by County Road 2. Joe will check and see if someone to serve can help.
