## Canoe & Kayak Storage Agreement

Enjoy the convenience of storing your canoe or kayak next to Lake Pepin.

**Storage Costs:** \$100 for the season (May through October). Price is per one rack space.

**Boat Storage Rules:**

Use: The property shall be used solely for use for storage of non-motorized canoes and kayaks and for related equipment and supplies. Hazardous and/or flammable materials may not be stored on the rental storage rack.

1. Storage racks are for watercraft only, no other property may be stored without permission.
2. Your boat(s) must be stored in a manner that does not interfere with other storage rack users or the general public. Watercraft must be contained wholly within the assigned rack spot and must not impede access to other rack spots.
3. The security of boat and equipment is the sole responsibility of the boat owner. Florence Township is not responsible for damaged or stolen boats and equipment. Renter must provide their own locking device. Florence Township accepts no liability for damage to, or security of, renter's property. It is mandatory that your craft be secured by your own device to the assigned rack at BOTH the front and the rear. This is to prevent the possibility of the canoe/kayak coming loose during high winds. When this occurs, damage to other canoes/kayaks could be considered the liability of the Renter who failed to have renter's canoe/kayak secured at both ends.

4. Paddles and oars may be stored on-site but must be secured to the rack within the renter's rack space. All other equipment must either be removed or stored inside the boat.

5. Area around the storage rack must be kept clean and orderly.

6. Renters will not alter the rack or fixtures.

7. Any damage or theft should be reported to Florence Township immediately.

8. Watercraft must be removed prior to the expiration of the period of the rental agreement.

9. Watercraft found in violation may be removed by Florence Township. Fees for removal and storage may be assessed.

10. There will be no refunds of a canoe/kayak rack rental fee.

11. Canoe/kayak rack rentals will not be ongoing from season to season. All applicants must reapply each year, with priority given to returning renters.

If dislodging and damage occurs, the damage to other canoes/kayaks will be considered the liability of the boat owner who failed to adequately secure the watercraft.

\_\_\_ Applicant agrees to assume all risks incident to or in connection with the rental and use of the canoe rack/storage and shall be solely responsible for all accidents or injuries of any kind.

\_\_\_ Applicant further agrees to indemnify and hold harmless Florence Township, and its employees from and against all claims, damages, losses and expenses resulting from the rental and use of the canoe rack/storage according to this agreement.
